### YOUR ONCOLOGY PRACTICE'S DEDICATION TO PROVIDING QUALITY CARE

ASCO's Quality Oncology Practice Initiative (QOPI<sup>®</sup>) is a voluntary, self-assessment and improvement program launched by ASCO in 2006 to help hematology oncology and medical oncology practices assess the quality of the care they provide to patients. QOPI<sup>®</sup> analyzes individual practice data and compares it to more than 100 quality measures. The information is then provided in reports to participating practices, and they can compare their performance to that of other practices across the country.

To achieve QOPI<sup>®</sup> Certification, this oncology practice participated in QOPI<sup>®</sup> and met or exceeded a benchmark score on measures that compared the quality of their care against national standards. Your practice then underwent an on-site review and peer review by a select team of oncology professionals, such as physicians and nurses to evaluate the practice's performance in areas that affect patient care and safety. The areas evaluated include:

- Qualifications of practice staff
- Chart documentation
- Chemotherapy preparation and administration
- Patient monitoring and assessment
- Preparedness for emergency situations.

Those practices that earn the QOPI<sup>®</sup> Certification designation have scored well on these and other QOPI<sup>®</sup> quality measures and have met chemotherapy safety standards established by ASCO and the Oncology Nursing Society.

### INTERNATIONAL EXPANSION

ASCO has been expanding both QOPI<sup>®</sup> and QOPI<sup>®</sup> Certification Program internationally. Currently, there are QOPI<sup>®</sup> Certified practices in Brazil, Greece, and Spain that have met nationally recognized standards for quality cancer care for outpatient hematology-oncology practices.
